### THE VISION

SBET is an independent betting platform running on the blockchain, where no KYC is needed, and participants can create their own betting pools including in the metaverse.





### THE VISION

The SBET platform has as goal to establish an anonymous, and straight forward solution for the sport betting industry. SBET seeks scalability and flexibility, allowing small betting businesses and single users to have more control over their own bets and transactions. The use of metaverse and NTFs betting are also in the scope of the SBET platform.

Participants can bet on existing events, create their own events or join as bidders. Optionally participants will be able to donate a desired amount to charity and NGOs. There is no man in the middle interaction on the SBET platform.

### MORE **PROBLEMS**



#### **Betting scams & frauds**

Many casinos and end users are target of cyber crime and fraud organizations. Bad actors will very likely attempt to steal customer private data. Some fraudsters will trick the participants and steal their money or accounts.



#### **Biased & rogue regulators**

In many countries betting laws are complex, with numerous federaland state-level regulations. In other countries, such laws are abused by corrupt states, other countries act as monopoly in the industry, while in some is illegal.



#### **Lack of Transparency**

In the context of online sports betting, two things of major concern are fairness and transparency. Participants want to know that there are no anomalies that may affect outcomes over the long-term.



### THE **SOLUTION**



**No need of KYC process** to join the platform, all you need is a wallet, thus no sensitive data is required nor stored in the SBET platform. The anonymity of participants are preserved and so their privacy.



**Instant and fast pay-outs.** Ensuring pay-out is also something that the blockchain can solve through the use of smart contracts. If a betting club or company gets closed the pay-out process wont be affected.



**No restrictions.** SBET is a permissionless platorm, meaning anyone can join, without any geo restrictions and participants have no betting amount limit.



**Fair and transparent.** No one can manipulate the logic of the platform. Everyone can see what is happening under the hood. A distributed immutable ledger could track that the pay-outs of a game correspond to the long-term frequency of those outcomes.

- Users can bet anonymously
- The platform is permissionless

- Poor user experience
- Risk of pump and dump
- Lack of features in the app
- Fewer sport category to bet




### THE **SBET PROTOCOL**

#### Donation Pool


Participants can donate if they feel so, of course the donators stay anonymous

#### Token Swap


To avoid massive pump and dump, the betting will be done with the SBET token.

Thanks to 5G being deployed world wide, users will be able to enjoy real time content without any problems. It's a multi trillion dollar opportunity waiting to be explored.






### THE **METAVERSE**

The metaverse massively boosts commercial interoperability. Allowing real time shopping and advertisement take another level.



Special cameras are used to improve users experience.










#### **Step 4 Donation pool**


Implementation of a donation smart contract in the platform.


